### CONFIDENTIAL ACCOUNT APPLICATION & SALES AGREEMENT

This Sales Agreement, as amended from time to time ("Agreement") establishes the terms and conditions under which "Encore Cellular Int'l Inc." sells mobile phones and accessories and other products as amended from time to time. For greater clarity, this Agreement will take precedence over and apply to the exclusion of any other verbal or written agreement prior to this date.

## 1 PRICES AND PAYMENT

- 1.1 Buyer will pay the prices specified in Encore Cellular Int'l Inc. pricelist as modified from time to time by notice to buyer. Unless otherwise stated, these prices do not include taxes.
- 1.2 Unless otherwise stipulated, payments are due prior to shipment.
- Buyer will provide security for its payment obligations in the form of a personal guarantee. Buyer will assume all debts and obligations incurred.
- 1.4 Interest will accrue on payments not made when due at the rate of 2% per month, calculated daily and compounded monthly.
- 1.5 Encore Cellular Int'l Inc.'s delivery obligations are conditional upon Buyer's ability to pay on a timely basis.

### 2 <u>TERM AND TERMINATION OF AGREEMENT</u>

- 2.1 This Agreement will become effective upon the date of signing by both parties and will remain in force unless terminated by either party by a minimum of three months written notice.
- 2.2 Encore Cellular Int'l Inc. may, at its discretion, either suspend or terminate this agreement, if:
- 2.2.1 Buyer's financial situation deteriorates to such an extent that Encore Cellular Int'l Inc. in its sole discretion has reason to believe that Buyer will be unable to fulfill its obligations under this agreement, or
- 2.2.2 Buyer does not fulfill his obligations under this Agreement.
